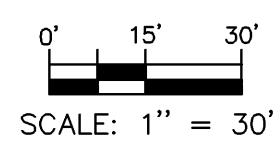
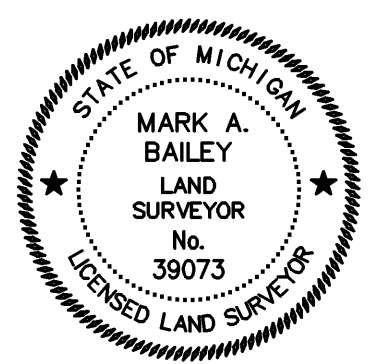


Description:  
 Lots 18 and 19, Orchard Plat (Liber 15 of Plats, Page 18) and part of the SW 1/4, Section 24, T6N, R13W, Georgetown Township, Ottawa County, Michigan, described as: Commencing at the W 1/4 corner of Section 24; thence S89°36'11"E 1326.19 feet along the North line of said SW 1/4; thence S00°06'50"W 999.74 feet along the East line of the NW 1/4 of said SW 1/4 to the centerline of Port Sheldon Road; thence S83°20'00"W 293.11 feet along said centerline to the PLACE OF BEGINNING of this description; thence S00°05'00"E 207.93 feet; thence S18°37'11"W 179.48 feet; thence S89°55'00"W 157.66 feet along the South line of said Lot 19 extended to the SW corner of said Lot 19; thence Northeasterly 44.41 feet along the West line of said Lot 19 (also being the East line of Poinsetta Street) on a 100.00 foot radius curve to the right, the chord of which bears N25°03'31"E 44.04 feet; thence Northeasterly 109.94 feet along said West line on a 166.00 foot radius curve to the left, the chord of which bears N18°48'25"E 107.94 feet to the SW corner of said Lot 18; thence N00°05'00"W 174.00 feet along the West line of said Lot 18 (also being the East line of Poinsetta Street) to the NW corner of said Lot 18; thence N83°20'00"E 79.52 feet along the North line of said Lot 18 (also being the South line of Port Sheldon Road) to the NE corner of said Lot 18; thence N00°05'00"W 43.29 feet along the East line of said Orchard Plat to the centerline of Port Sheldon Road; thence N83°20'00"E 83.10 feet along said centerline to the place of beginning. The Northerly 33 feet thereof subject to the Right-of-Way for Port Sheldon Road. Containing 1.245 Acres including Right-of-Way and 1.182 Acres excluding Right-of-Way.
