**#210419-09 – Server Replacement for Township Office**

The Superintendent discussed with the Committee that the back-up server for the Township Office quit working about two years ago. The current frontline server is now five years old and has had a couple recent issues that have caused some concern. In 2018, the Township Board had approved the purchase of a new server to go along with new office computers. The Superintendent did not purchase a new server at that time as the frontline server was only two years old and the back-up was working. The Superintendent asked the Committee if he may still act under the 2018 approval to purchase a new server.

The consensus of the Committee was that the Superintendent may still act under the 2018 approval and purchase a new frontline server for approximately \$13,000, and that the current frontline server will become a back-up.
